

EXHIBITOR CONTRACT
36th ANNUAL PHOENIX SURGICAL SYMPOSIUM

Hyatt Regency Phoenix at Civic Plaza, February 13 – 16, 2008

This is a 4-day post-graduate course sponsored by Banner Health CME in educational partnership with the Phoenix Surgical Society, and is designed to present a review of current knowledge. Expected attendance is 150-250 physicians practicing in Surgery, plus all area surgical residents. Accreditation includes ACCME Category 1. Course director: Sam Casano, MD. Exhibits will set up after 6:00 pm on Tuesday, and take down after 4:00 pm on Friday. Exhibit times are as follows: Wed. and Fri.: During breakfast, mid-morning and mid-afternoon breaks. Thursday: During breakfast and mid-morning break. **NO exhibits on Saturday.** A confirmation letter and schedule will be mailed upon receipt of contract. **PAYMENT IS DUE IN FULL by February 13, 2008.**

Exhibitor assumes entire responsibility and thereby agrees to protect, indemnify, defend and save Banner Health CME and the Phoenix Surgical Society (known as the Sponsors) and the Hyatt Regency Phoenix at Civic Plaza and their employees and agents harmless against all claims, losses, and damages to persons or property, governmental charges or fines and attorney's fees arising out of or caused by exhibitor's installation, removal, maintenance, or occupancy or use of the exhibition premises or a part, thereof, excluding any such liability caused by the sole negligence of the Hyatt Regency Phoenix at Civic Plaza or their employees and agents. In addition, Exhibitor acknowledges that the sponsors and the Hyatt Regency Phoenix at Civic Plaza do not maintain insurance covering exhibitors' property and that it is the sole responsibility of exhibitor to obtain business interruption and property damage insurance covering such losses by exhibitor. The exhibitor shall obtain and keep in force during the term of installation and use of the exhibit premises the policies of Comprehensive General Liability and Contractual Liability Insurance, insurance and specifically referring to contractual liability set forth in the foregoing paragraph, thereof, in the amount not less than \$250,000 combined single limit for personal injury and property damage. The Internal Revenue Service issued Regulation 1,513.3 regarding taxability of exhibitor's sales activity at conventions and trade shows. Under this regulation these activities are allowed by 501(c)(3) and 501(c)(6) organizations as a related activity and therefore not taxable. The regulation does not exempt exhibitor sales from sales tax and thus any sales activity by an exhibitor must be reported to the appropriate taxing authority by the exhibitor.

In accordance with the Standards of Commercial Support for Continuing Medical Education of the Accreditation Council for Continuing Medical Education, all promotional commercial products will be confined to the exhibit area.
